\_\_\_\_\_ I have completed a house check by a member of 831pawdyguard Rescue and have taken the appropriate measures to ensure the safety of the animal. Anything found to be unacceptable or a potential hazard has been corrected or submitted to maintenance for an immediate correction.

\_\_\_\_\_ I have completed an overnight trial (1 to 14 days) and have discussed my concerns. I acknowledge that there are no issues that would prevent me or my family from continuing to care for this animal.

\_\_\_\_\_ I am aware that the animal has been spayed/neutered and has been cleared by a certified medical professional. If the animal has not yet been altered, I am receiving the animal as a foster-to-adopt; adoption is complete once the surgery is completed.

\_\_\_\_\_ I agree to take the animal for annual exams for health checks and vaccinations. Any procedure or medication recommended is my decision and responsibility under the guidance of a certified medical professional.

\_\_\_\_\_ I agree that this animal will not be declawed or otherwise altered in any way not directly related to its health, safety, or quality of life.

\_\_\_\_\_ I agree that this animal will not be given or sold to a facility with the purpose of cosmetically altering or experimentation.

\_\_\_\_\_ I agree that neither I nor anyone in my immediate family has been convicted or suspected of animal cruelty, neglect, or abuse.

\_\_\_\_\_ I agree to provide the adequate amount of food, water, exercise, and care for this animal.

\_\_\_\_\_ I agree that this contract expires only if the animal is returned to this Rescue or when its life comes to an end.

\_\_\_\_\_ I agree that if this contract is broken, the animal is found to be in an unsafe environment, or neglect/abuse has been determined, 8331pawdyguard Rescue has the right to confiscate the animal and/or seek legal recourse.

\_\_\_\_\_ I have been given access to all medical records and acknowledge that there are no guarantees that the temperament or physical condition of the animal will remain the same after this agreement is signed and the animal is in my care.

\_\_\_\_\_ I understand that this animal has never bitten, attacked, or otherwise harmed a human or another animal while in the care of this Rescue. 831pawdyguard Rescue is not liable for any future signs of aggression.

\*\*If an incident has occurred previously and the animal has been cleared by a medical professional, an incident report will be signed by both 831pawdyguard Rescue and the adopter.

831pawdyguard Rescue is committed to providing a lifetime of quality care to each of the animals fostered and adopted through the program. This contract releases this Rescue from all liability, effective \_\_\_\_\_, 20\_\_\_\_\_.
